

### **Background:**

Major Gifts are defined by LSSU Advancement as gifts received in excess of \$10,000. The following summary represents the recent major gift activity in support of the University's current key initiatives since the September meeting.

A grant consultant was retained to identify potential grant funders in support of select LSSU strategic priorities. The consultant also provides background information on each grantor, a calendar of submission dates, and proposal review services.

<u>Major Gifts</u>: A generous gift of \$46,915.20 was received from the Clifford Bryce Nesseth Trust. The funds from this trust beneficiary gift will establish the Clifford and Pearl Nesseth Memorial Scholarship. Bryce directed that the trust proceeds create an endowment to honor his parents. The named endowment will provide financial assistance to LSSU students majoring in a College of Great Lakes Ecology and Education program who are pursuing a degree with a focus on fisheries, fresh water quality, or soil conservation. The first award will be given in the 2025-2026 academic year.

A gift of \$38,898.07 was received from the Kaleel D Jones & Josephine I Jones Charitable Trust. The annual spendable proceeds from the named trust support two named scholarships – the Kaleel & Josephine Jones Scholarship and the John Williams Jones VIII. The Kaleel & Josephine Jones Scholarship supports students majoring in engineering, nursing and education. The John Williams Jones VIII Scholarship supports students majoring in the criminal justice program.

A gift of \$21,981.65 was received from the Henry & Ruth Norvell Charitable Trust. This trust beneficiary gift is in support of Laker Hockey. Ruth Norvell was a long time LSSU employee. She and her husband were long-time Laker Hockey supporters. Ruth passed away in 2002. Upon Henry's passing in 2023, the Trust directed a distribution to LSSU.

William and Pamela Bacheler made a generous gift of \$39,562.91 through an IRA Distribution to fund the William & Pamela Bacheler Family Fisheries & Wildlife Scholarship (\$19,562.91), the LSSU Track and Cross Country Team (\$10,000) and the Bud Mansfield Student Emergency Fund (\$10,000).

The Wildshore Foundation, Inc. made a \$10,000.00 gift in support of the LSSU Undesignated Fund.

H. James and Ann Bourque made a \$10,000.00 gift in support of the Laker Men's Basketball Facility Renovation Campaign.

Michelle Somes-Booher and Douglas Booher made a gift of \$13,700.00 to establish the Corydon L and Nancy R Somes Scholarship to honor Michelle's parents. Her father, Corydon Somes, who passed away in 2022, was a Sault High graduate, Soo Tech alumnus and former LSSU Board of Trustee member. The endowment will benefit an incoming freshman who is a graduate of Michigan's UP pursuing a degree in any course of study at LSSU. The first award will be given in the 2024-2025 academic year.

### **Purpose:**

This agenda item provides a summary of the LSSU Advancement's recent Annual Fundraising and LSSU Alumni Relations activities.

### **Background:**

Annual Fundraising activities provide financial support for University initiatives and assist in the identification of potential major gift donors. Alumni Relations activities and communications facilitate the initial engagement of alumni and friends to LSSU beginning the cultivation process for joining the Alumni Membership Program and potential future giving.

Launched two new larger programs to support annual giving through Laker Club

- Pledge Per
  - New program for men's and women's basketball, men's and women's ACHA Hockey, and D1 hockey supporters to pledge per goal and assist (hockey), and pledge per rebound or 3-pointer (basketball).
  - **\$3,246** in gross donations was raised this year from the program.
  - Program includes a mix of new and existing donors, and has shown tremendous value in gathering up-to-date contact information on new, first time donors.
- Laker Meal Sponsor Program

- Starting with hockey, alumni can now sponsor a team meal on the road. Donors receive recognition via a social media shout-out thanking them for providing the team road meal. To date, **\$12,250** was raised for the season.
- Men's Basketball raised over **\$2,000** during their playoff run as part of the program.
- Volleyball has started to solicit gifts for next season.
- Additional sports will continue to be added.

#### Laker Men's Basketball Locker Room Renovation Campaign

The Laker Men's Basketball Locker Room Renovation Campaign is nearing its conclusion, as **\$205,000** of the **\$225,000** goal has been committed to the project.

### Annual Give-a-thon (Phone-a-thon)

#### **Purpose:**

The purpose of this submittal is to provide a summary of the linkage between the LSSU BOT approved strategic plan with LSSU Legislative Affairs and LSSU Advancement.

#### **Background:**

The following DRAFT dashboards provide a multi-year comparison between key legislative priorities. For example, once approved by the LSSU BOT, traditionally a state capital outlay is necessary for any capital campaign undertaking. Capital outlays provide 75% of the funding for projects like the Richard and Theresa Barch Center for Freshwater Research and Education, with the remaining 25% raised through a capital campaign.

Other legislative work is connected with LSSU strategic priorities and the higher education budget, which includes funding for LSSU and priorities like the Budget, Tuition, ITEMS (infrastructure, technology, equipment, maintenance, and safety), ITW (Indian tuition waiver), and MPSERS (Michigan public schools employee retirement system).

#### **Purpose:**

The purpose of this submittal is to provide a summary of the linkage between LSSU Advancement and LSSU Alumni Relations activities with the University's strategic plan.

#### **Background:**

The LSSU Board of Trustees approved a five-year strategic plan entitled; *Superior Education, Superior Experience, Superior You* at a special board meeting on April 24, 2020. This strategic plan will serve as a road map guiding our activities in support of the applicable strategies during this period.

2.3.1 Increase the number of annual and endowed scholarships targeting students from disadvantaged financial backgrounds.

Ongoing work with Deans, faculty and staff to encourage a coordinated effort around philanthropic outreach to increase scholarships, endowments and proposals in support of the LSSU Strategic Plan.

• This quarter, there is one new scholarship, the Clifford and Pearl Nesseth Memorial Scholarship, and an endowment builder fund, the Wesley DeJong Jr. Legacy Endowment, was established with funds donated over the last year.

The Clifford and Pearl Nesseth Memorial Scholarship will provide financial assistance to LSSU students majoring in a College of Great Lakes Ecology and Education program who are pursuing a degree with a focus on fisheries, fresh water quality, or soil conservation.

The distribution of the Wesley DeJong Jr. Legacy Endowment spendable funds will be awarded based on requests from the Laker Athletic equipment managers to address immediate equipment or priority needs of their respected DI or DII program.

- To date for FY24, 86 gifts to annual scholarships and endowments have been made totaling \$ \$780,611.00.
- 2.3.5 Increase and maintain a funding source for student emergencies.

The Bud Mansfield Student Emergency Fund is an ongoing fundraising priority for LSSU.

The new Soo Co-Op endowment will in part support Seamore's Closet, a food-bank available to all students at no charge.

2.3.6 Increase grant support to benefit students from socioeconomically disadvantaged backgrounds.

A grant consultant was retained to increase grant support for LSSU overall. A new Grant section has been added to the Major Gift section.

2.4.2 Increase communications highlighting successes, accomplishments, and key initiatives of students, faculty, staff, and alumni across multiple platforms and when possible invite community participation.

Campus Highlights 2021-22 was created and distributed in coordination with MarComm which will highlight LSSU successes.

The spring edition of the Laker Log e-magazine is released in May. Laker E-ffect enewsletters are released monthly, highlighting campus news/initiatives and highlighting alumni success.

3.2.14 Review the organizational structure of University Advancement and reorganize it for maximum fundraising effectiveness.

Transferred authority to award faculty and student grants to Provost, connecting strategic plan with academics and philanthropy.

Provost and Deans are now part of the Alumni Award selection committee.

Provost, Deans, Marketing, and Student Affairs are now part of GLSW planning.

3.2.15 Develop long-term fundraising goals in support of University strategic initiatives.

The Vice President of Advancement is currently developing goals for the upcoming fiscal year, including:

- Quantifying and surpassing the number and/or amount of annual major gifts acquired (\$10k+), and the number of new donors acquired annually.
- Developing a process for identifying, vetting, prioritizing, budgeting and coordinating resources needed in support of the strategic plan.
- Adhoc meetings are now set up with the Dean's to discuss grants and priorities.
- 4.2.1 Create and share a reference list of key contacts at LSSU and the community for ease of communication.

4.2.2 Develop and maintain a promotional system in support of LSSU events and summer activities to broaden exposure, participation, and engagement.

Work continues with Marketing & Communications to develop campus wide calendar to realize economies of scale to promote and leverage efforts throughout campus.

Invitations to BOT members are going out for special events including GLSW, and the Detroit professional team games partnering with LSSU.

4.2.3 Increase awareness of LSSU programs that meet regional job market demands and offer future opportunities in step with economic trends.

Sharing LSSU Career Services information in issues of the Laker Log and on the alumni social media pages.

Career Fair during Great Lake State Weekend.

4.5.5 Enhance the opportunities for alumni and friends of the University to advance the institution with their time and resources.

Shared strategic plan with Alumni Association and Advancement to align their goals with LSSU's.

### Secondary Strategies:

3.1.3 Develop a process for review/assessment that ensures expenditures are aligned with institutionally approved plans (e.g. LSSU Strategic Plan, LSSU Master Plan, Housing Master Plan, and Facilities Master Plan).

Working on process to align philanthropic priorities with strategic plan. Process will require needs to be: Identified, vetted, prioritized, budgeted, and coordinated.

3.2.11 Increase miscellaneous General Fund revenue (e.g. miscellaneous gifts, interest Income, Norris Center revenue, Arts Center revenue, and indirect costs).

Laker Club communications will be targeted by sport specific demographics via e-mail, text and social media.

4.1.3 Assign a liaison to facilitate interaction between LSSU and the community for internship opportunities, job shadowing, and hiring after graduation.

President Gillette was a key-note speaker at the 2023 Annual Chamber Luncheon.

The relationship with MyMichigan Hospital and Bay Mills Community College has grown significantly in recent months through individual meetings and a new nursing related partnership between the three.

On Dec 4, 2023 LSSU hosted a City Commission meeting for the first time. President Gillette has been invited to speak.

Beginning 2024, LSSU flags will be hung on Ashmun St. and Portage Ave. from July 5 through GLSW.

4.5.1 University leadership will collaborate with local political, business, and community leaders.

Staff actively involved with Chippewa County Historical Society and Sault Ste. Marie's Sunrise Rotary.

Advancement team member Andrew Rubinstein is a member of the Sault Ste Marie City Commission.

Interim President Gillette continues to attend many personal and group meetings.
