

Background:

Major Gifts are defined by LSSU Advancement as gifts received in excess of \$10,000. The following summary represents the recent major gift activity in support of the University's current key initiatives since the September meeting.

A grant consultant was retained to identify potential grant funders in support of select LSSU strategic priorities. The consultant also provides background information on each grantor, a calendar of submission dates, and proposal review services.

Major Gifts: An anonymous gift of \$125,000 was made in support of the newly established Laker Hockey Legacy Advancement Fund which supports the men's D1 hockey program at LSSU.

Richard Gulliver made a \$15,000 gift supporting the Teneyck-Gulliver Nursing Scholarship in honor of his late wife Marjorie, who was a 1949 Soo Tech alum and a graduate of the Sparrow Hospital School of Nursing. Their scholarship benefits a sophomore nursing student who demonstrates a dedication and commitment to a career in the nursing field.

Michael Hart made \$10,000 gift in support of the Philip A. Hart Memorial Scholarship. Michael Hart is an LSSU alum and son of Senator Philip A. Hart. He is great benefactor to the prestigious endowment that honors the late Senator Hart's legacy.

JC and Tammy Huizenga made a \$10,000 (Donor Advised Fund) gift supporting the School of Engineering and Technology. Mr. Huizenga is a long-time benefactor of the LSSU School of Engineering. He received the Donald and Catherine Finlayson Award in 2011, which is presented to an individual who has enjoyed success in their profession and community and who is a strong advocate of the University.

Lisa Jirikovic made a \$10,089 stock gift creating an annual scholarship called the *David Jirikovic Memorial Scholarship*, in memory of her husband, David Jirikovic. The scholarship will be awarded to a member of the LSSU cross country or track team for the fall 2025-26 academic year.

Sharon and Paul Moggach made a \$40,000 gift through an IRA in support of the Laker Hockey Program.

Kim and Nancy Strawe made a gift of \$29,500, with \$22,000 in support of the Barch Center for Freshwater Research and Education, and \$7,500 to provide a \$2,500 annual scholarship and to establish an endowment benefitting students majoring in the Fisheries and Wildlife Management programs who also have an appreciation for the outdoor environment. Kim Strawe is 1968 alumnus.

Family and friends of the LSSU Men's and Women's Club Hockey teams donated through an online donation support platform called Vertical Raise, in support of these programs. The total raised was \$23,567, with \$11,829 in support of the men's club, and \$11,738 supporting the women's club.

Grants:

A grant consultant was retained to identify funding opportunities for LSSU based on a list of LSSU priorities.

To date 56 prospective grant making organizations have been identified.

Other legislative work is connected with LSSU strategic priorities and the higher education budget, which includes funding for LSSU and priorities like the Budget, Tuition, ITEMS (infrastructure, technology, equipment, maintenance, and safety), and ITW (Indian tuition waiver). Note, MPSERS (Michigan public schools employee retirement system) has been funded and will be removed.

The Prison Program and ensuring all eight paths to financial aid are available for those students is also a priority being tracked. If and when that occurs, Michigan will be the first state in the nation to allow it.
